Sub: Granting of Affiliation

Sir

I am directed to state that Hon'bleVice-Chancellor has been pleased to grant affiliation to your B.Ed. College with effect from the academic session 2014-15, subject to the approval of the University Council in its next meeting and the recognition of the NCTE and also subject to fulfilment of the following conditions-

- 1. The course fee is Rs. 65 thousand (sixty five thousand) only and the payment can be accepted only by A/C payee Cheque/ Demand Draft. No extra fee, in any form, can be taken.
- 2. The annual intake is 100 (One Hundred), out of which 50 seats for the freshers and the remaining 50 for the deputed teachers. The permission of the University is mandatory to convert the seats for the freshers to those for the deputed teachers and vice- versa.
- 3.An amount of Rs. 41000/- (Forty -one thousand) has to be deposited to the University immediately.
- 4. The admission process, including advertisement, can commence only after recognition by NCTE.
- 5. The College has to come under Central Counselling network of the University for the purpose of admission.
- 6. The pay and allowances of the teachers/ faculty must follow the latest UGC, NCTE and State Government norms. The payment to the staff has to be made through A/C payee Cheque drawn on a (preferably) Nationalized Bank.
- 7. The Security of service of the teaching and non-teaching staff has to be ensured.
- 8. The Governing Body of the College has to be constituted as per the University Statute within one month from the commencement of the academic and administrative activities of the College.
